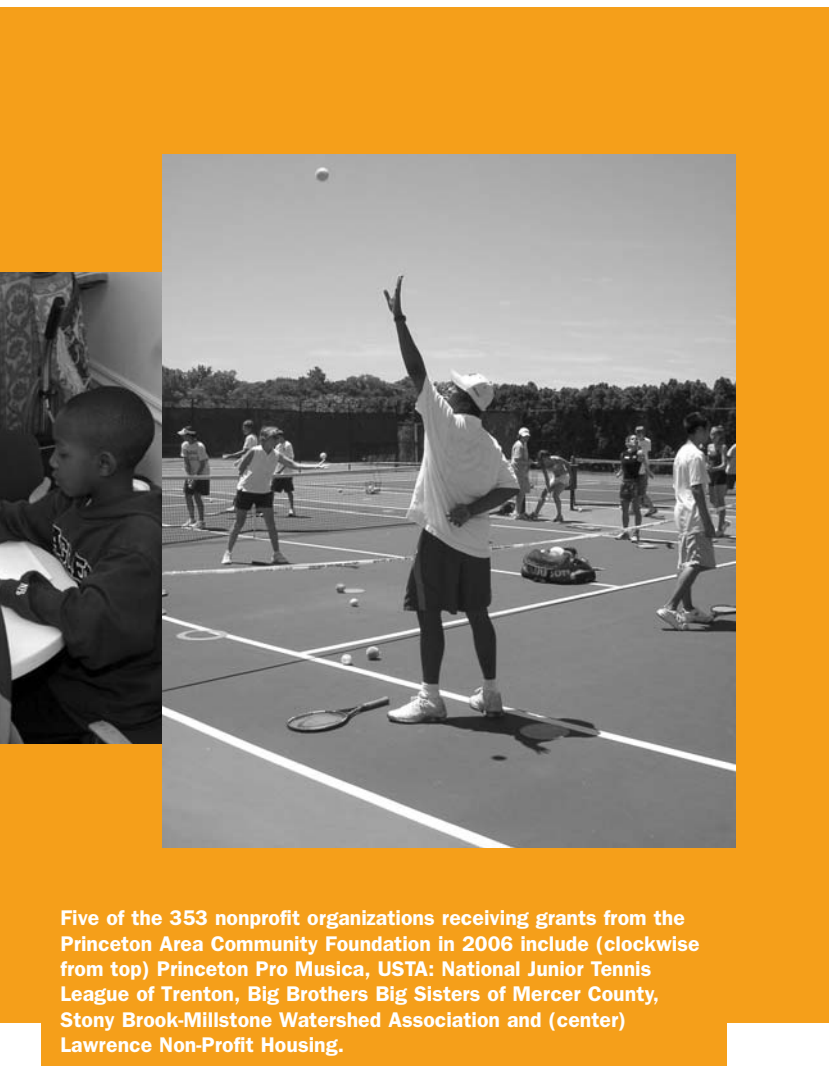

What is a Community Foundation?

A community foundation is a simple and ingenious organization designed to make it possible for anyone to support their community now and in the future. It attracts charitable dollars, manages and invests the money, and gives money through grants to support nonprofits.

Community foundations are defined by the geography they serve, with a broad mission to encourage philanthropy. They manage many charitable funds under one roof.

Community foundations have a long-term view and a broad perspective. They have deep roots in community, experience working with nonprofits, and are a knowledge bank for local philanthropy.

The impact of a community foundation is evident in its permanence on the one hand, and its flexibility on the other.

What is PACF?

The Princeton Area Community Foundation is the community foundation for greater Mercer County and central New Jersey; and is the only Nationally Certified Community Foundation in the State. We work to build community using philanthropy as our tool.

The charitable funds created at the Community Foundation are supported by thousands of people in the area who believe that they can accomplish more working together than they can alone. The Community Foundation belongs to the region — it is community-run and community-focused.

The Princeton Area Community Foundation is a member of the Council of New Jersey Grantmakers, and the Council on Foundations, and subscribes to COF's Principles and Practices for Effective Grantmaking which sets forth well-recognized good practices.

The Community Foundation also subscribes to the Association of Fundraising Professionals Donor Bill of Rights, the National Committee on Planned Giving's Model Standards of Practice for the Charitable Gift Planner, and adheres to our board approved confidentiality policy. The Community Foundation is also a member of the Mercer Regional and Princeton Regional Chambers of Commerce.

What are National Standards?

National Standards for community foundations are a set of benchmarks intended as a blueprint for internal operational development and an external assessment of performance. The 43 Standards address key issues of governance, development, accountability, leadership and communications.

The certification process is a rigorous peer review by experienced and trained professionals at the Council on Foundations based in Washington, DC.

Your fund can be tailored to fit your charitable vision and priorities. If you wish, your fund's grantmaking can be facilitated by the Community Foundation to meet the greatest needs in the community now and in the future.

Funds Can Be Directed

You can designate a particular organization, community, or issue to be supported. You can create a scholarship in memory of a loved one. You can also establish a fund that allows you to be more actively involved by suggesting grants from your fund.

Funds Bring You Benefits

No matter the size of your fund, all donors enjoy the benefits and services of the Community Foundation. Funds are pooled and invested for maximum stability and growth. You can tap the knowledge of our staff to help guide your individual grantmaking.

Which fund is right for you?

When you establish a fund at the Community Foundation, you choose a percentage of your fund to be distributed annually based on your giving priorities. You may name the fund whatever you wish. It can carry your family name as a permanent memorial or it can be anonymous. You can choose among several fund types:

Community Building Funds

When you create a community building fund, you help support local nonprofit organizations to address emerging needs and changing community priorities.

Field-of-Interest Funds

Create one of these funds when you wish to support organizations within a general area of charitable interest, such as education, health, social services, the arts; or in a geographic region.

Advised Funds

If you are considering a private foundation to facilitate your charitable giving, the following questions could help you decide what philanthropic vehicle is right for you.

What type of tax deductions do you wish to take?

Because the Community Foundation is a publicly supported 501(c)3 nonprofit organization, gifts to your fund enjoy the maximum tax deductibility.

With a Community Foundation fund, all administration and tax reporting is provided by the Community Foundation. We can also provide staff assistance for grantmaking.

A fund at the Community Foundation can be created in less than a day with no set-up fees.

Grants from Community Building, Field of Interest, and Scholarship Funds are awarded through an open competitive process overseen by the Community Foundation's Grants and Advisory Committees.

Advised, Designated, and Agency Endowment grants are made in consultation with individuals or groups of donors to support the organizations and interests they care most about.

Greater Mercer Grants multi-tiered approach to building and supporting community

Addressing Community-wide Efforts

Grants of up to \$50,000 are made to nonprofit organizations to form community-wide efforts to address a shared problem or take advantage of a shared opportunity, either within a single municipality (borough, city, township) or among many. Projects that address shared interests such as community planning, economic development, civic engagement, service sharing and delivery, volunteerism, the environment, and participatory arts, are eligible, as are activities that bring people together to examine barriers to connecting with each other. Ongoing activities receive priority.

Addressing Concerns and Opportunities in Low-Income Neighborhoods

Grants of up to \$20,000 are made to nonprofits, neighborhood associations, and groups of residents to work together on a neighborhood project. Projects may address such issues as safety, health, housing, neighborhood improvement/ beautification, recreation, or neighborhood based social opportunities. Projects offering multiple opportunities for neighbors to come together receive priority.

Addressing the Needs of Low-Income Individuals and Families

Grants of up to \$15,000 are made to nonprofits that demonstrate they can help low-income individuals and/or families. Projects may address needs in one or more areas, such as economic self-sufficiency, education, health, housing, nutrition, safety, supportive services, or youth development. The Community Foundation seeks projects with the greatest potential to make a meaningful and sustained difference in people's lives.

Q&A

Q: How did PACF decide to focus on community building?

A: We had a decade of grantmaking experience under our belt. We knew we did good grantmaking, but we wanted to do better grantmaking — great grantmaking, something with cumulative and substantial impact. In 2005 we undertook a year of research and deliberation. And we went to the community and asked its advice. We talked to lots of people who know the area's issues and needs best — residents, community leaders, nonprofit staff, policy experts.

Q: What did this research show?

A: Our research pointed to a primary role for the Community Foundation in building community. It was clear we did not want to abandon our tradition of funding projects that help low-income residents so we still direct significant resources to these needs. But our major grantmaking focus now is on community building — that is, encouraging residents to solve problems and make the most of opportunities, together.

Q: Can you give us some examples of how this new focus can build community?

A: When we support the “Crossing Borders” work of People & Stories/Gente y Cuentos, we encourage a program that exposes participants to the rewards of literature. But beyond that, we support a program that brings together urban, suburban and rural residents from all over Mercer County and uses literature discussions as a way for them to meet and get to know each other — to explore similarities and differences. This builds community. Another example is a recent grant to the Trenton Downtown Association for programs hosted at the Classics Bookstore. Quality, family-friendly, and interactive recreational and educational activities bring together residents of Trenton and surrounding towns. In the words of a participant, “A miracle has happened in downtown Trenton. The community has undergone a transformation. Families and friends are enjoying themselves in downtown Trenton in the evening. On Friday nights, Warren Street is bustling with activity because of Classics. As a result, neighboring restaurants and businesses are thriving and criminal activity has diminished.”

Q: Is community building a stretch for PACF to pursue?

A: Not at all. For years our mission has been to connect people who care with causes that matter and community building is all about connecting people. We also facilitate community building whenever we bring people together or provide information and referrals, which we do every day.

Q: What is so important about bringing people together around an issue?

A: When people come together, information flows, relationships are built, resources are shared — knowledge, skills, contact lists, time, and money. Trust and respect grow. Once people come together around one issue, they build relationships that help them work together on others. The resulting network of connections is called social capital.

Q: This sounds pretty “touchy-feely.” Is social capital measurable?

A: Yes. Researchers at Harvard have found that social capital has declined dramatically over the last three decades because people are not connecting on many levels. We hear about it all the time. Families no longer eat dinner together. Neighbors are not watching out for each other and often don't even know each other. Organizational membership has taken a nose dive. Voter turnout continues to decline. Regional problems are not being adequately addressed because municipalities are working in isolation. And yet the social capital derived from these kinds of connections makes an enormous difference in our lives, collectively and individually.

Q: What can we expect when our community increases its amount of social capital?

A: Our community is likely to have better performing governmental institutions, higher educational achievement, faster economic growth, and less crime and violence. Community members are likelier to report being happier, healthier and to have a longer life expectancy. In places with greater social connectedness it is easier to mobilize people to tackle problems and arrange things that benefit the community as a whole. These benefits are why the Community Foundation is investing in building community.

Q: How does the Community Foundation invest its money?

A: The Community Foundation's charitable assets held for long-term grant-making are invested in The Permanent Pool — a pool of investments created specifically for PACF. The Investment Committee monitors the Pool's performance on a quarterly basis and oversees our investment policy.

What is the Community Foundation's investment objective?

The Permanent Pool has a long-term time horizon and is structured with the objective of achieving returns greater than the combined total of PACF's spending policy, administrative costs, and inflation. All of the investment management firms are nationally renowned. The guiding philosophy of the Pool's management is to promote the prudent stewardship of funds entrusted to the Community Foundation for the benefit of the community of donors and charitable organizations we serve.

The Community Foundation uses a total return approach to investment management. Total return describes the change in fund value over a given time period resulting from interest, dividends, and capital appreciation as a result of both realized and unrealized gains.

What is the Community Foundation's investment strategy?

The Permanent Pool is broadly diversified across asset classes and investment styles in order to enhance investment results in all market environments.

An important part of the Community Foundation's portfolio is its asset allocation which includes domestic and international stocks and bonds and alternative assets (real estate and private equity).

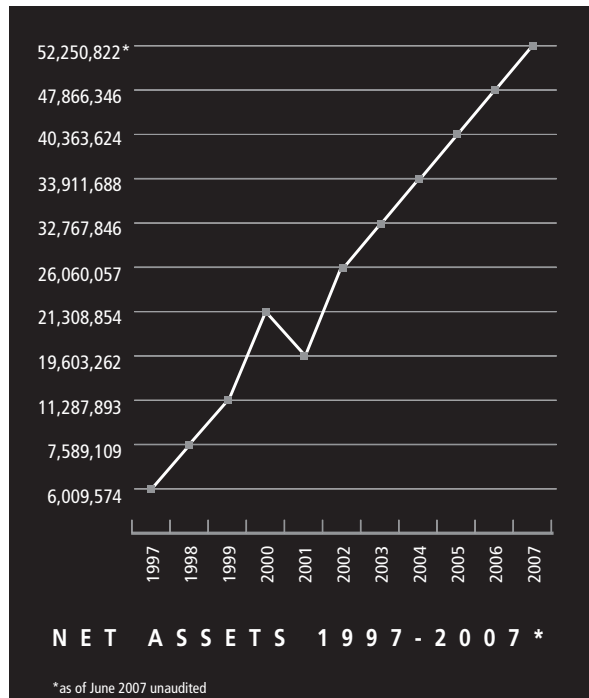
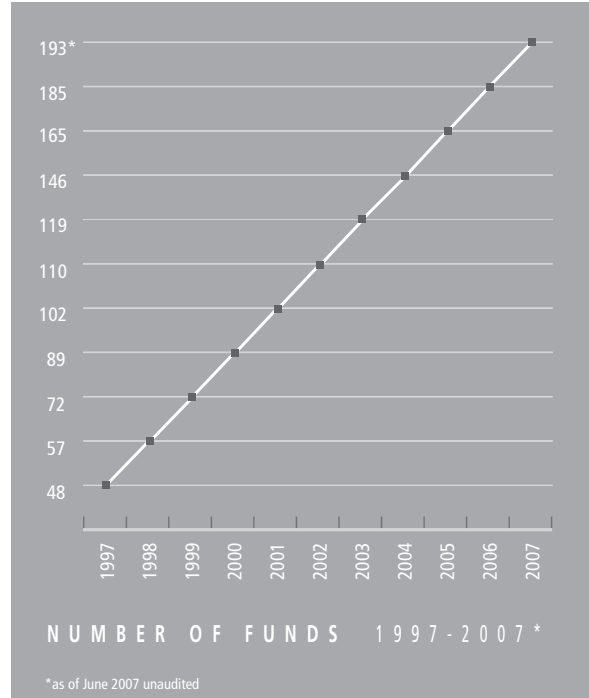

Why do other nonprofits bring their agency endowment to the Community Foundation?

Partnering with the Community Foundation allows organizations to focus on their core mission while taking advantage of the Community Foundation's professional and diversified investment management, planned giving, and endowment fundraising support.

How does the Community Foundation work with private foundations?

Private foundations work with PACF when they need an advisor, mentor, facilitator, or convener. Some create a parallel advised fund to their private foundation, which allows them to access PACF's grantmaking and services without changing their current private foundation structure.

Others meet their annual payout requirement by making one grant each year to PACF which can then disburse grants as recommended by the fund's advisors, usually the private foundation's trustees. This simplifies tax reporting while the private foundation continues to guide its own investment strategy.

Some private foundations have decided to transfer all assets to an advised fund at PACF for ease of administration, grantmaking guidance, efficient investment management, elimination of the mandatory annual payout, and when desired, to provide anonymity for donors, trustees, and fund advisors.

How does the Community Foundation support corporate giving programs?

PACF assists corporations with the set up of their corporate giving program — training staff, assisting with the development of program mission, focus, guidelines, infrastructure, and process.

A corporation can simply advise grants from their fund to nonprofits they recommend. The Community Foundation handles the entire transaction from due diligence on potential grantees to issuing grant letters and awards to nonprofits. PACF oversees investments and fund administration, provides statements of all grants and gifts to simplify bookkeeping for a company's charitable activities, and provides ongoing counsel, advice, and public relations assistance.

The Community Foundation can also assist with the identification of organizations to support, sponsor education programs about topics relevant to philanthropy, and meet with employees to discuss their own personal philanthropic needs and charitable giving goals.

Q: Who are the people behind the Community Foundation?

A: The Community Foundation is overseen by a volunteer Board of Trustees and championed by our Associates and former trustees.
