

What is the Legacy Society?

The Princeton Area Community Foundation established the Legacy Society to recognize people who are planning gifts today that will provide significant benefits to our community in the future. These gifts may take the form of bequests, charitable remainder trusts, gifts of life insurance, or other charitable planned gift.

Our community is already the beneficiary of thousands of gifts entrusted to the Community Foundation by generous people. Sometimes such gifts go unrecognized because they come at the end of the donor's life. The Legacy Society provides a way for the Community Foundation to recognize and thank donors during their lifetimes, and to design plans for funds that result from such gifts.

Members of the Legacy Society are recognized in the Community Foundation's printed materials and invited to periodic events. Community Foundation staff is available to Society members and their professional advisors to discuss estate and gift planning questions and concerns.

How do I become a member?

You are already eligible for membership in the Legacy Society if you have made arrangements in your will or through some other form of deferred giving, for a gift to the Princeton Area Community Foundation. Simply notify us of your plans by completing the form on the back of this sheet and returning it to us.

You may tailor your charitable gift to fit your personal situation. We can help determine a plan that works for you. Your current or future gifts of cash, securities, real estate or other resources can help our community and initiate your membership in the Legacy Society.

Once we know your intentions, we can assist you in making more precise arrangements for how the Community Foundation will use your gift.
